Smt. Poonam Singh & Himanshu Singh Jadaon , availed home loan A/c no. **504781426131** (TL), facility from Indian Bank, DELHI GATE-SANJAY Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt. Poonam Singh & Himanshu Singh Jadaon failed to pay the outstanding dues to the Bank. As Smt. Poonam Singh & Himanshu Singh Jadaon (Borrower), Account No.: **504781426131** (TL) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18.03.2023 after complying with all legal formalities.

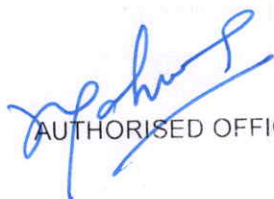
