- f. being 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **15/06/2026** at 05:00 PM.
- g. Auction would commence at Reserve Price, as mentioned above.
