

Vrindavan ashram celebrates BJP's electoral wins

Saints and devotees at Shri Hanuman Tekri Ashram celebrated the BJP's decisive victory in the Assembly elections in West Bengal, Assam and Puducherry on Monday.

The celebration was led by Bhagwat speaker Dr Manoj Mohan Shastri, where saints and locals exchanged sweets and raised slogans praising Lord Hanuman and Bharat Mata. Acharya Badrish said the results reflected public support for Prime Minister Narendra Modi and cultural

nationalism. Mahant Mohini Bihari Sharan Maharaj termed the victory a triumph of truth and good governance. Addressing the gathering, Dr Shastri said the results rejected negative politics and reaffirmed faith in development, democracy and Sanatan culture.

RIPPLE EFFECT: Bengal verdict to shape UP 2027 battle

With BJP set to form government in Bengal, political nerves are visible not only in Kolkata but also in Lucknow. The stakes extend far beyond government formation in one state. The outcome is being closely watched as a potential trigger for the 2027 Uttar Pradesh Assembly elections.

For the BJP, a decisive win in Bengal would be more than just capturing a state long dominated by Mamata Banerjee. It would mark a significant ideological and political breakthrough in eastern India. Such a result would also help the party recover from the relative setback it faced in Uttar Pradesh during the

2024 Lok Sabha elections. A victory in Bengal would allow the BJP to reinforce its governance narrative, particularly the model associated with Chief Minister Yogi Adityanath. Built around welfare delivery, infrastructure expansion and a strong law and order framework, the so called Uttar Pradesh model has been a central theme in the party's campaign.

During rallies, Adityanath repeatedly highlighted this approach. "The Uttar Pradesh model stands on security, development and cultural pride. Investment is growing, governance is transparent, and people are directly benefiting," he said, while also underlining welfare schemes such as free ration and housing as key pillars of governance.

Five killed, seven injured as SUV rams truck in Odisha

At least five people, including two women, were killed and seven others injured when an SUV in which they were travelling rammed into a truck in Odisha's Jajpur district on Monday, police said.

The accident took place near Barada Chhak on the Daitary-Paradeep express highway under Jenapur police station limits in Jajpur district.

Odisha Chief Minister Mohan Charan Majhi expressed grief over the accident and expressed his condolences to the families of the deceased. He also announced an assistance of Rs 4 lakh from the Chief Minister's Relief Fund (CMRF) to the next of kin of each deceased.

'FISH CURRY RICE' STILL STAPLE IN BENGAL UNDER BJP

Amid Trinamool Congress (TMC) claims that the Bharatiya Janata Party (BJP) would stop non-vegetarian food if it comes to power in West Bengal, the saffron camp served the Bengali staple fish curry-rice after securing a majority. Speaking to the media

while cooking at the party headquarters in Salt Lake near Kolkata, a chef said the special menu included doi mach, fish cooked with curd.

"Along with doi mach, there is rice, mixed vegetable curry and sweets. This food is for everyone," the chef said. BJP supporters were also

seen eating jhaal muri and chicken biryani while celebrating the party's victory.

During the campaign, TMC supremo Mamata Banerjee had repeatedly cited examples from Uttar Pradesh and Bihar to claim that the BJP would ban fish and other non-vegetarian items.

PORTION OF BRIDGE OVER GANGA COLLAPSES IN BIHAR

A portion of the Vikramshila Setu, which connects Bihar's Purvanchal region to the Seemanchal region in north Bihar, collapsed into the Ganga river in Bhagalpur district at around 1.10am on Monday, disrupting traffic.

District authorities said the incident occurred around 12.50am near pillar number 133, when a gap formed between two slabs, followed by a section falling into the river. Officials acted swiftly and cleared vehicles and commuters from the area, preventing any injuries. Sources said police personnel

noticed signs of ground subsidence and cracks near the same pillar around 11.33pm on Sunday. Senior officials were alerted, and vehi-

cles had already been evacuated, preventing a major accident involving buses bound for Muzaffarpur and Araria.

All movement across the bridge has been halted, and traffic diverted towards Munger and Sultanganj. Entry of heavy vehicles into Bhagalpur city and the Zero Mile area has also been stopped.

Bihar State Bridge Construction Corporation chairman Chandrashekhar Singh said Chief Minister Samrat Choudhary has spoken to the Defence Minister and the Army Chief to arrange alternative connectivity with support from the Border Roads Organisation and the Army. Boat and steamer services have been introduced, and repairs are expected within three months.

RJD WINS A SEAT IN KERALA

Even as Lalu Prasad's RJD faced defeat in the last Bihar Assembly election, the party registered its first-ever win in the Kerala Assembly elections.

RJD candidate P K Praveen won the Kuthuparamba seat in Kannur district as part of the Left Democratic Front. He defeated Jayanthi Rajan of the Indian Union Muslim League by 1,286 votes. Praveen secured 70,448 votes, while Rajan

polled 69,162. BJP candidate Shijilal finished third with 22,195 votes.

RJD spokesperson Chittaranjan Gagan said the party contested three seats, winning one and finishing second in Kalpetta and Badagara.
