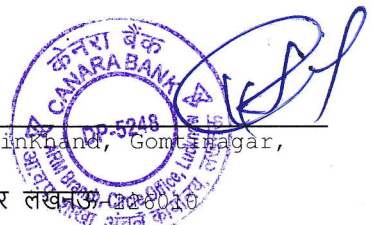
9 Other terms and conditions:
