As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due **Rs. 50,75,048.51 (Rupees Fifty Lacs Seventy Five Thousand Forty Eight and Paise Fifty One only)** as on **23.12.2025**, with further interest, charges & expenses thereon due to the Indian Bank.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

The date of sale is fixed as 05.06.2026 which would be by e-auction mode.
