M/s Shiv Shakti Plywood Prop Mr. Jitendra Bahadur (Proprietorship Firm), availed OCC& Term Loan facility from Indian Bank Branch:Tambour, the repayment of which is secured by Mortgage of schedule mentioned properties herein after referred to as "the Properties". Mr. Jitendra Bahadur S/o Mr. Shiv Bux Singh (Proprietor/ Mortgagor/ (Guarantor)) failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 07.01.2026.

District Sitapur Pin 261202, Mr. Jitendra Bahadur S/o Mr. Shiv Bux Singh (Proprietor/ Mortgagor/ (Guarantor)R/o Vill Moiya Post Khanpur, Sitapur Pin 261202, District Sitapur Pin 261303 failed to make payment despite Demand Notice, the Authorized Officer took Possession of the schedule mentioned properties under the Act on 17.03.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days'** notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 01.05.2026 is **Rs. 1,34,74,465.00 (Rupees One Crore Thirty Four Lakh Seaventy Four Thousand Four Hundred Sixty Five Only)** with further interest, costs, other charges and expenses thereon from 02.05.2026.

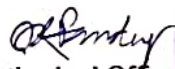
