Mrs.Lalita Devi Saw (Borrower/Mortgagor), Mr. Saw Rahul Dilip (Co-borrower) availed Housing Loan facility from Indian Bank, Madhya Bazar Branch, Purulia, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs.Lalita Devi Saw and Mr. Saw Rahul Dilip failed to pay the outstanding dues to the Bank. Mrs.Lalita Devi Saw (Borrower/Mortgagor/Proprietor), Mr. Saw Rahul Dilip (Co-borrower) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.03.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
