Mr G Selvam and Mrs S Sarasu availed home loan facility from Indian Bank, Palladam Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the properties". **Mr G Selvam and Mrs S Sarasu** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 21.01.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / Mortgagor(s) and Guarantor(s) **Mr G Selvam and Mrs S Sarasu** is liable to the Bank to pay the amount due to the tune of **Rs. 19,22,313/- (Rupees Nineteen Lakhs Twenty Two Thousand Three hundred and Thirteen Only)** for Home loan, Home loan plus and GMRA as on 15.08.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 16.08.2024 and paper publication of Demand Notice in The Times of India (English) and Dina Thanthi (Tamil) on 16.10.2024.

As **Mr G Selvam and Mrs S Sarasu** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21.12.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice

The amount due as on 19.05.2026 is Rs 24,86,033.62/- (Rupees Twenty Four Lakhs Eighty Six Thousand and Thirty Three and Sixty Two Paise Only) with further interest, costs, other charges and expenses thereon from 20.05.2026.
