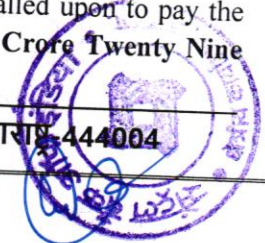

Terms and Conditions of E-Auction

1. The sale will be done by the undersigned through e-auction platform provided at the Website <https://baanknet.com/> on 27/05/2026 (12.00 Noon to 06.00 PM) & date of inspection of the property is 26/05/2026 from 12.00 Noon to 03.00 P M. The intending Bidders/Purchasers are requested to register on portal (<https://baanknet.com/>) using their mobile number and email-id. Further they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take minimum 2 working days), **the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time. In case EMD amount is not available in Global EMD Wallet, system will not allow to bid.** The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Bidders may give offers either for one or for all the properties. Only after having sufficient EMD in his Wallet, the interested bidder will be able to bid on the date of e-auction. 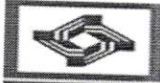

6. In case of any difficulty or assistance is required before or during e-auction process they may contact authorized representative if our e-auction Service Provider (www.https://baanknet.com/.in), details of which are available on the e-auction portal.
7. The bidder who submits the highest bid amount (not below the Reserve Price) on the closure of the e-auction process shall be declared as a successful bidder by the Authorised Officer/ Secured Creditor, after required verification.
8.
