

IIT-BHU faculty selected as INSA Young Associate 2026

Varanasi: Aditya Kumar Padhi, assistant professor at the School of Biochemical Engineering, Indian Institute of Technology (IIT-BHU), has been selected as a Young Associate of the Indian National Science Academy (INSA-YA) for the year 2026 under the category 'Biological, Structural Biology and Drug Discovery'.

In a remarkable achievement, Padhi is the only researcher selected nationally in this category this year and also the sole awardee from IIT-BHU, bringing immense pride and recognition to the Institute. Padhi's research focuses on the interdisciplinary domains of Computational Biology, Structural and Translational Bioinformatics, Biomolecular Modelling and Simulations, and AI/ML-driven therapeutic discovery. His work integrates advanced approaches such as protein design, molecular dynamics simulations, machine learning, QM/MM methods, and multi-scale modelling to study disease mechanisms, pathogen evolution, antimicrobial resistance, and biomolecular interactions.

His work also extends to protein engineering, mutation forecasting, infectious disease research, and data-driven development.



BHU reforms to make PhD admissions more transparent, time-bound

Varanasi: The academic council of BHU has approved a series of reforms aimed at making the PhD admissions process more accessible, transparent and student-friendly. The meeting was held on Wednesday under the chairmanship of Prof. Ajit Kumar Chaturvedi.

One of the key proposals passed by the council allows university departments to conduct a screening test before interviews for PhD admissions. It required, earlier, all eligible candidates could directly appear for interviews. Under the new system, departments will have the flexibility to shortlist candidates through a screening examination before the interview.

Officials said the format and operational details of the screening test will be decided by a university-level committee, whose formation has also been approved by the council. Another major reform approved during the meeting provides for preparation of a combined merit list of main subjects and allied subjects for PhD admissions. Candidates securing positions in the combined merit list will be granted admission to the concerned department, removing the earlier distinction between main and allied subjects. VC Prof. Chaturvedi said the reforms would help attract talented students from across the country and ensure timely screening of admissions and academic schedules.

Arms used in VB CM As murder seized

One More Accused Held In Ballia

Varanasi: A CBI team recovered three pistols and two revolvers allegedly used in the May 6 murder of West Bengal chief minister Suvendu Adhikari's personal assistant, Choudhary Nath following the arrest of another accused in Ballia on the intervening night of Tuesday and Wednesday.

In a joint operation with STP, Varanasi field unit, the CBI arrested Naveen Kumar Singh of Thamnahanpura from Bismupur, an FIR under the Arms Act was lodged at the District Police Station, Tuesday. The STP's seizure list included a 9mm pistol, two .32 bore pistols, two revolvers, 45 live cartridges, nine empty shells and a mobile phone. During initial questioning, Naveen told officials that Gyanendra Pratap Singh alias Mannu of Sheel Dawa had come to his house in a car on May 7 with associates Rajkumar Singh and Golu Singh. Mannu handed him a bag of arms and ammunition and asked him to keep it at home. Naveen claimed that he panicked after seeing the news of Rajkumar's arrest and hid the bag in his warehouse along NH-31. The STP later took him to the warehouse and recovered the cache.

The CBI has also intensified its search for Gyanendra, who allegedly purchased a second-hand Nissan Micra from a local, Satyan Singh, which was used in the crime. Naveen and Gyanendra came under the CBI radar following the interrogation of recently arrested Rajkumar Singh and Vinay Rai, alias Purnima, from Ballia and Varanasi.

Before Naveen's arrest, the CBI team had visited the house of Satyan, who sold the car to Naveen, and the Ballia-based alleged contract killer Gyanendra. Satyan's father, Jitendra Singh, of Phulwaria village, said the CBI sought details of the car. Satyan had bought it from a Lucknow resident through his friend Deepak alias Mithu for Rs 35,000 in Oct 2025. Despite repeated requests, Mithu kept delaying the transfer of papers to Satyan's name. On May 1, Mithu convinced Satyan to take the car to Mannu for Rs 50,000. Again, no registration transfer was done.

Agencies are now hunting for Gyanendra, their prime target. Active in crime since 2008, he has 12 cases — mostly murder — and was booked under the Gangsters Act in 2023.

As the search intensified, an old video of him firing 30 rounds in rapid succession at village head Musesh Singh went viral on social media. Photos of Gyanendra and Rajkumar with arms have also surfaced.

Rajkumar Singh of Ratpur village, Rasra, Ballia, was returning from Haridwar when CBI caught him at a Muzaffarnagar toll plaza on May 17. Another prime accused, Vinay Rai, alias Purnima of Ghazipur, wanted since May 9, was arrested from the Police Lines area in Varanasi on May 19 evening. The third accused, Thakur Rai Singh, who arrested from Ayodhya, was released following the CBI's submission that he had been arrested mistakenly.

Another arrest in fake jewellery loan fraud case

Varanasi: Gopiganj police in Bhadohi district arrested one Ajay Kumar associated with Raju Seth gang involved in criminal activities like certifying fake jewellery as real jewellery for seeking gold loan from banks illegally.

Bhadohi Superintendent of Police Abhinav Tyagi said that Seth and 21 other members of his gang, including



Ajay Kumar, were hooked under the Gangsters Act.

Police said that this gang caused intentional financial losses to banks for gain by certifying fake jewellery as real jewellery. Seth and his associates were booked in cases under charges of committing forgery, fraud and criminal conspiracy to cause loss to the banks.

While searching the members of this gang the Gopiganj cops succeeded in nabbing Ajay of Narepur Upward, police added.
