Mr.Shaju P A, S/o-Panikkaveetil Aboobacker and Mrs.Sameena A, W/o-Mr.Shaju P A have availed loan facility from Indian Bank, M O Road, Thrissur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Shaju P A, S/o-Panikkaveetil Aboobacker and Mrs.Sameena A, W/o-Mr.Shaju P A failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.05.2023 (published in newspaper on 19.11.2023) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr.Shaju P A, S/o-Panikkaveetil Aboobacker and Mrs.Sameena A, W/o-Mr.Shaju P A liable to the Bank to pay the amount due to the tune of Rs.2407276.96 (Rupees Twenty four Lac seven thousand two hundred seventy six and ninety six paise only) as on 18.05.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 18.05.2023.

As Mr.Shaju P A, S/o-Panikkaveetil Aboobacker and Mrs.Sameena A, W/o-Mr.Shaju P A failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 27.02.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **20.05.2026** is **Rs.32,56,065/- (Rupees Thirty two lakhs fifty six thousand sixty five only)** with further interest, costs, other charges and expenses thereon from **21.05.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 30.06.2026 which would be by e-auction mode.
