**M/S Hari Om Enterprises** availed MSME Loan from Indian Bank, Bandra East Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/S Hari Om Enterprises** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.05.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **M/S Hari Om Enterprises , Shri Dwariknath C Mishra (Partner & Mortgagor), Mr Lal Bahadur Rajpal (Partner), Mr Vinod C Mishra(Partner)** liable to the Bank to pay the amount due to the tune of **Rs.55,62,491.00** (Rs Fifty Five Lakhs Sixty Two





thousand Four Hundred Ninety One Only) as on 21.05.2024 with further interest, costs, other charges and expenses thereon. You failed to make payment despite Demand Notice dated 21.05.2024.

All of you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **26.08.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
