Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

M/s. Cyraj Instruments, Represented by his Partners : Prabin K Rajendran & Binish A had availed loan facilities from Indian Bank, Madras George Town Branch, the repayment of which are secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s. Cyraj Instruments, Represented by his Partners : Prabin K Rajendran & Binish A** had failed to pay the outstanding, therefore a Demand Notice dated **14.01.2026** under Sec 13(2) of Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorised Officer calling upon **M/s. Cyraj Instruments, Represented by his Partners : Prabin K Rajendran & Binish A** liable to the Bank to pay the total amount due to the tune of **Rs.3,09,62,937/- (Rupees Three crores nine lakhs sixty two thousand nine hundred and thirty seven only)** with further interest, cost and other charges and expenses thereon. Both failed to make payment despite Notice dated **14.01.2026**.

As **M/s. Cyraj Instruments, Represented by his Partners : Prabin K Rajendran & Binish A** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **20.03.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The total amount due as on **19.05.2026** is **Rs.3,25,97,812/- (Rupees Three crores twenty five lakhs ninety seven thousand eight hundred and twelve only)** with further interest, costs, other charges and expenses thereon from **20.05.2026**.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 24.06.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
