M/S Royal Bazar through its Proprietor Sri Rahul PathakS/o Sri Ramshankar Pathak availed loan facility from Indian Bank, Kutchery Road, Robertsganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/S Royal Bazar through its Proprietor Mr. Rahul Pathak S/o Sri Ramshankar Pathak failed to pay the outstanding dues to the Bank. liable to the Bank to pay the amount due to the tune of - **Rs. 12023995.00 (Rupees One Crore Twenty Lakh twenty three thousand nine hundred and ninety five only)** as on **15/09/2025** with further interest, costs, other charges and expenses thereon. All failed to make payment despite **Demand Notice dated 15/09/2025**.

As M/s. Royal Bazar, Proprietor Mr. Rahul Pathak failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **20/11/2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **15/09/2025** is **Rs. Rs. 12023995.00 (Rupees One Crore Twenty Lakh twenty three thousand nine hundred and ninety five only)** with further interest, costs, other charges and expenses thereon.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 05.06.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **16.05.2026** to **03.06.2026** between **10.00 am to 4.00 pm**.
