NOTICE OF INTENDED SALE

Notice of intended sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub: Your SME Account No. 755921830-OCC, 6201848530-PMEGP, 6772689009-TL, 7097655159-KCC with Indian Bank, Sholapuram Branch.

Mr. S Sankar availed SME facility from Indian Bank, Sholapuram Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Sankar failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 03.12.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mr. S Sankar and Guarantor(s) Mrs. Geetha Rani liable to the Bank to pay the amount due to the tune of **Rs.82,17,624.00 (Rupees Eighty two lakh seventeen thousand six hundred and twenty four Only)** as on 02.12.2022 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 03.12.2022.

As Mr. S Sankar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.02.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 22.05.2026 is **Rs. 81,72,163.00 (Rupees Eighty-one Lakhs Seventy-two Thousand One hundred and Sixty three Only)** with further interest, costs, other charges and expenses thereon from 23.05.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 15.06.2026 which would be by e-auction mode.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefor.
