Mr. M. Arul Pandiyan availed AGMTL facility from Indian Bank, Portonovo Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. M. Arul Pandiyan GGfailed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **10/09/2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Mr. M. Arul Pandiyan, Guarantor Mr. Shanmugam, Guarantor Mrs. Vijaya liable to the Bank to pay the amount due to the tune of **Rs. 38,71,458/. (Rupees Thirty- Eight Lakh Seventy - One Thousand Four Hundred Fifty- Eight Only)** as on 09.09.205 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10.09.2025

As Borrower Mr. M. Arul Pandiyan, Guarantor Mr. Shanmugam, Guarantor Mrs. Vijaya failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **12/05/2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION
ADOPTING THE e-AUCTION MODE.**

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days** notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 26/05/2026 is **Rs.42,36,715/- (Rupees Forty-Two Lakh Thirty- Six Thousand Seven Hundred Fifteen Only)** with further interest, costs, other charges and expenses thereon from 27/05/2026.

Please take note that this is notice of **30 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 29th June 2026 from 11.00 AM to 4.00 PM which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **29/06/2026** i.e the e-Auction Date and before the e-auction end time in the portal.
