M/s G S Automobiles (Partnership Firm) through its partners Mrs. Kiran Jaiswal W/o Mr. Guptar Nath Jaiswal and Mrs. Veena Jaiswal W/o Mr. Sharad Kumar Jaiswal availed Cash Credit (Acc No. 50321726059) and Term Loan (Account No. 7130345276) facility from Indian Bank, Hazratganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s M/s G S Automobiles (Partnership Firm) through its partners Mrs. Kiran Jaiswal W/o Mr. Guptar Nath Jaiswal and Mrs. Veena Jaiswal W/o Mr. Sharad Kumar Jaiswal failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 08.10.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon 1. M/s G S Automobiles (Partnership Firm), 2. Mrs. Kiran Jaiswal W/o Mr. Guptar Nath Jaiswal (Partner/ Guarantor), 3. Mrs. Veena Jaiswal W/o Mr. Sharad Kumar Jaiswal (Partner/ Guarantor), 4. Mr. Guptar Nath Jaiswal S/o Late Guru Prasad Jaiswal (Guarantor/ Mortgagor), 5. Mr. Sharad Kumar Jaiswal S/o Late Guru Prasad Jaiswal (Guarantor/ Mortgagor), 6. Ms. Sakshi Jaiswal D/o Mr. Guptar Nath Jaiswal (Guarantor/ Mortgagor) liable to the Bank to pay the amount due to the tune of Rs. 36647145.33 (Rupees Three Crore Sixty- Six Lakhs Forty-Seven Thousand One Hundred Forty-Five and Thirty-Three Paise Only) as on 07.10.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 08.10.2025.

As M/s M/s G S Automobiles (Partnership Firm) through its partners Mrs. Kiran Jaiswal W/o Mr. Guptar Nath Jaiswal and Mrs. Veena Jaiswal W/o Mr. Sharad Kumar Jaiswal failed to make payment despite Demand Notice, the Authorized Officer took Symbolic possession of the schedule mentioned properties under the Act on 12.12.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **07.10.2025** is **Rs. 36647145.33 (Rupees Three Crore Sixty- Six Lakhs Forty-Seven Thousand One Hundred Forty-Five and Thirty-Three Paise Only)** with further interest, costs, other charges and expenses thereon from **08.10.2025**.

Please take note that this is notice of **15** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15** days.

The date of sale is fixed as 24.06.2026 which would be by e-auction mode.

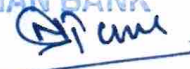
The sale is subject to confirmation by the Secured Creditor.

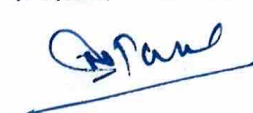
