Ms. Agasti food and Agro industries Prop. Janaradhan Shinde and others had availed **MSME TL** facilities and facilities mentioned above from Indian Bank, Ahmadnagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". 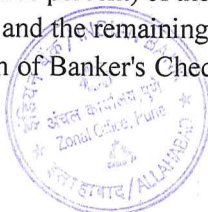

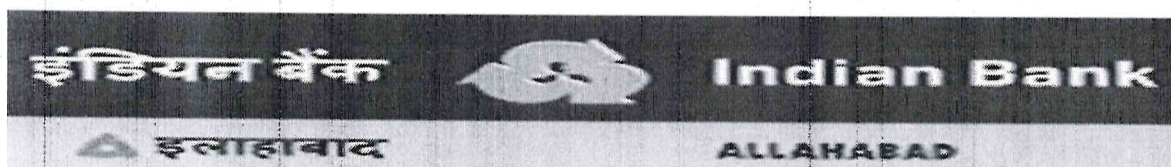

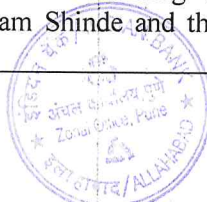
