M/s Mahesh Sweets and Dairy Needs availed OCC and TL facilities from Indian Bank, Agra Kalindi Vihar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Mahesh Sweets and Dairy Needs failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 16.03.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s)- **M/s Mahesh Sweets and Dairy Needs (Prop. Mahesh Singh) Mr. Mahesh Singh s/o Mr. Ashok Kumar (Proprietor);** Guarantor(s)- **Mr. Ashok Kumar s/o Mr. Kamal Singh and Mrs. Bhoori Devi w/o Mr. Ashok Kumar** liable to the Bank to pay the amount due to the tune of 16,09,191/- (Rupees Six Lakh Nine Thousand One Hundred Ninety One only) as on 16.03.2022 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 16.03.2022

As M/s Mahesh Sweets and Dairy Needs failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 04.06.2022 after complying with all legal formalities.

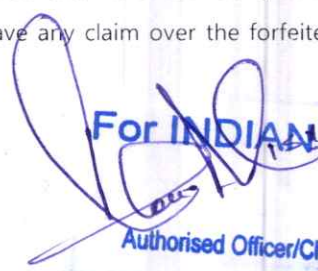
