M/s Jha Enterprises (Propreitor: Hari Om Jha), availed 50093076514 (OCC), facility from Indian Bank, Hotel Clarks Shiraj Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Jha Enterprises (Propreitor: Hari Om Jha), failed to pay the outstanding dues to the Bank. 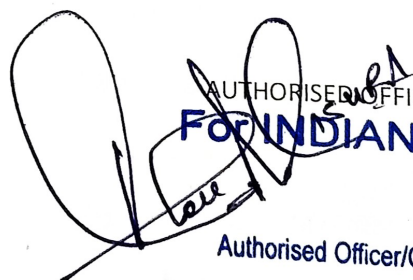
