Mr. Abhishek Singh S/o Mr. Mahendra Singh availed a Term loan facility from Indian Bank, **G. T. Road, Fatehpur** Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Abhishek Singh S/o Mr. Mahendra Singh** failed to pay the outstanding dues to the Bank. Liable to the Bank to pay the amount due to the tune Rs. 6,85,385.00 (Rupees Six Lakh Eighty Five Thousand Three Hundred and Eighty Five only) as on 15.12.2025 with further interest, costs, other charges and expenses thereon. **Mr. Abhishek Singh S/o Mr. Mahendra Singh** failed to make payment despite Demand Notice dated – 16.12.2025. ▶

As **Mr. Abhishek Singh S/o Mr. Mahendra Singh** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.05.2026 after complying with all legal formalities.



As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 24.05.2026 is Rs. tune **Rs. 7,16,984/- (Rupees Seven Lakh Sixteen Thousand Nine Hundred and Eighty Four Only)** with further interest, costs, other charges and expenses thereon from 25.05.2026.
