the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the borrowers". The borrowers failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 22.01.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s)- Mr Amit Singh S/o Mr. Anuj Pratap Singh. The borrowers liable to the Bank to pay the amount due to the tune of Rs. 37,66,783.00 (Rs. Thirty Seven Lakhs Sixty Six Thousand Seven Hundred and Eighty Three only) w.e.f. 22.01.2026 along with cost of charges and expenses further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 22.01.2026.

As the borrowers failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 07.04.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 20.05.2026 is of **Rs.3904060.00 (Rupees Thirty-Nine Lakh Four Thousand Sixty Only)** along with cost of charges and expenses further interest, costs, other charges and expenses thereon **from 21.01.2026**.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as **24.06.2026** which would be by e-auction mode.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://baanknet.com> (PSB Alliance Pvt. Ltd.)) for depositing in bidders EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/cancel the sale without assigning any reason therefore.
