

# 4 railway divisions & 2 zones major hurdle for Tirupati dist

Development affected as Rail Ministry fails to address administrative issues

THE unique situation of Tirupati district being administered by four railway divisions under two different railway zones has emerged as a major administrative and technical bottleneck, delaying railway development projects and infrastructure expansion in one of the country's most important pilgrimage destinations.

The South Coast Railway (SCoR) and Southern Railway zone have four railway divisions, Chennai, Vijayawada, Guntur and Guntakal.

Tirupati and Renigunta fall under the Guntakal Division, while Puttur, Nagari, Naidupeta, and Sullurupeta fall under the Chennai Division.

The Srikalahasti-Nadikudi route comes under the Guntur Division, whereas Gudur Railway Station falls under the Vijayawada Division.

Speaking to *TNIE*, Balaji Railway Division (Tirupati) Sadhana Samithi Convener Kuppala Giridhar said that Tirupati district's railway development has been severely affected due to the Ministry of Railways' failure to address long-standing administrative issues arising from the district

being divided among two railway zones and four railway divisions.

Local railway activists claim that coordination between different divisions and zones often becomes a challenge, leading to delays in project execution.

The union leaders stressed that establishing a separate Tirupati-centric railway division is the need of the hour, as it would significantly improve administrative efficiency and accelerate development activities across the district. Former District Railway Users Consultative Commit-

tee (DRCCU) member Gundluru Venkataramana told *TNIE* that passenger traffic in the Tirupati region has been increasing steadily, and it deserves a dedicated railway administrative setup.

Political leaders, railway unions, and members of civil society from the Tirupati region have urged the Ministry of Railways to intervene and consider bringing the entire Tirupati district under a single railway zone and one railway division to ensure faster and more effective railway development.

## ‘DMK, AIADMK tried to join hands to stop TVK’

IN his first public speech after leading the Tamilaga Vettri Kazhagam (TVK) to victory in the Assembly elections, Chief Minister C Joseph Vijay on Monday launched a sharp attack on the DMK and AIADMK, alleging that both parties had attempted to come together to prevent the TVK from forming the government.

Vijay also reiterated his commitment to clean governance. "A corruption-free administration cannot be created overnight. It is not magic. But one day we will achieve it," he said. Addressing a thanksgiving meeting for voters at St Joseph's Higher Secondary School Grounds in Tiruchy, Vijay said, "Today they accuse us of horse-trading. But who was actually trying to join hands secretly?"

"Those who claimed to oppose each other for years were willing to unite only because they did not want a TVK government. They feared that if this government assumes power, bribery and loot would come to an end," he said. Without directly naming the parties, Vijay referred to the DMK as an "evil force" and the AI-



ADMK as an "empty force."

Asserting that the election results had transformed Tamil Nadu's political landscape, Vijay said politics in the State had for decades revolved around caste equations, religious divisions and money distribution during elections.

"The people rejected all that by choosing TVK," he said, adding that the party would continue to oppose caste and religious divisions while ensuring equal governance.

Responding to criticism that TVK's success was driven by social media influence, Vijay said, "They think people who posted reels on Instagram voted for us and brought us victory. Even if that's true, we have at least made an entire generation follow politics. Instead of analysing us from outside, understand what is happening inside your party."

## DKS, Siddhu to hold talks with high command

AHEAD of the swearing-in ceremony, Karnataka Chief Minister-designate DK Shivakumar and senior Congress leader Siddaramaiah are set to hold consultations with the party high command in Delhi today to finalise the contours of the new State cabinet.

The two leaders were expected to meet Congress leaders Rahul Gandhi, Mallikarjun Kharge and General Secretary (Organisation) KC Venugopal on Monday. However, sources said the meeting was postponed due to Rahul Gandhi's packed schedule.

Shivakumar, who was formally elected leader of the Congress Legislature Party in Karnataka on Saturday, will be sworn in as Chief Minister at 4:05 pm on Wednesday, along with a select group of ministers.

While sources said that 10 to 12 ministers would take oath alongside the Chief Minister, both Shivakumar and Siddaramaiah have arrived in Delhi.

Among the names being considered for ministerial births are Yathindra Siddaramaiah, Priyank Kharge, HC Mahadevappa, Santosh Lad and Zameer Ahmed Khan.

## 70 taken ill after having juice at temple fete

A Around 70 people, including children and adults, reportedly fell ill after consuming juice distributed during the Gammamma Jatara celebrations at Patapeta village in Baireddipalli mandal of Chittoor district. According to local sources, villagers commenced the annual Gammamma Jatara on Thursday.

As part of the festivities, a woman from the village prepared and distributed juice to devotees using an orange-coloured liquid concentrate reportedly brought from Tamil Nadu.

Soon after consuming the juice, nearly 70 people complained of health issues and became unwell.

On receiving information, Baireddipalli Primary Health Centre Medical Officer Dr Vijay Chander, along with his medical staff, rushed to the spot and provided immediate treatment to the affected persons.

The incident came to light on Monday. Health officials said all the patients responded well to treatment.
