NOTICE OF INTENDED SALE

Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mrs. P. Karnaki and Mr. Ganeshkumar availed Home Loan facility from Indian Bank, Portonovo Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. P. Karnaki and Mr. Ganeshkumar failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **23/01/2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Mrs. P. Karnaki and Co-Borrower Mr. Ganeshkumar, liable to the Bank to pay the amount due to the tune of Rs.7,43,007/. **(Rupees Seven Lakh Forty-Three Thousand Seven Only)** as on 23/01/2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 23/01/2026.

As Borrower Mrs. P. Karnaki and Co-Borrower Mr. Ganeshkumar, failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 12/05/2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security

Interest Act 2002, **30 days**-notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 26/05/2026 is **Rs.7,72,193/- (Rupees Seven Lakh Seventy-Two Thousand One Hundred Ninety-Three Only)** with further interest, costs, other charges and expenses thereon from 27/05/2026.

Please take note that this is notice of **30 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 29th June 2026 from 11.00 AM to 4.00 PM which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **01/06/2026 to 29/06/2026** between **11:00 AM to 4.00 PM**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their e-KYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **29/06/2026** i.e. the e-Auction Date and before the e-auction end time in the portal. The registration and e-KYC must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) **for depositing in bidders EMD Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefor.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
