Mr.R.Nithyanantham availed Home Loan facility from Indian Bank, Karambakudi Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.R.Nithyanantham failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.07.2015 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr.R.Nithyanantham (Borrower) and C.Sekar (Gurantor) liable to the Bank to pay the amount due to the tune of **Rs.10,47,668.93/- (Rupees Ten lakh forty seven thousand six hundred and six sixty eight and Ninety three paise only)** as on 03.07.2015 with further interest, costs, other charges and expenses thereon.Both failed to make payment despite Demand Notice dated **06.07.2015**

As Mr.R.Nithyanantham failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 22.09.2015 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION
ADOPTING THE e-AUCTION MODE.**

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 15.05.2026 is **Rs.29,65,129.- (Rupees Twenty Nine lakhs sixty five thousand one hundred twenty nine only)** with further interest, costs, other charges and expenses thereon from 15.05.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 05.06.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by **the intending purchasers/bidders may be done at their expense from 24.05.2026 to 04.05.2026 between 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 04.06.2026 i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://baanknet.com> (PSB Alliance Pvt.
