- The property/ies will not be sold below the Reserve Price.

- d. The property can be inspected with prior appointment with Authorized Officer from **04.06.2026 to 05.06.2026 between 03:00 PM to 05:00 PM.**
- e. The sale will be done by the undersigned through e-auction platform provided at the website <https://baanknet.com/> on the date and time mentioned above. The intending Bidders/purchasers are requested to register on portal (<https://baanknet.com/>) using their mobile number and email id (Buyer Registration Link provided in the home page of the website). Further intending Bidders/purchasers are requested to complete Registration and e-KYC and add Bank details.
