NOTICE OF INTENDED SALE

Late Sri. Balakrishnan S/o Ramachandran had availed aforementioned credit facility from Indian Bank, Portonovo Branch, and the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as "the Property". Sri. Balakrishnan S/O Ramachandran failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice, dated 14.07.2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Sri. Balakrishnan S/O Ramachandran liable to the Bank to pay the amount due to the tune of Rs.13,77,187/- (Rupees Thirteen Lakh Seventy-Seven Thousand One Hundred Eighty-Seven only) as on 14.07.2021 with further interest, costs, other charges and expenses thereon. Sri. Balakrishnan S/O Ramachandran failed to make payment despite Demand Notice dated 14.07.2021

As the above named borrower failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 19/11/2021 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days** Notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 19/05/2026 is **Rs. 31,84,622/- (Rupees Thirty-One Lakh Eighty-Four Thousand Six Hundred Twenty-Two only)** with further interest, costs, other charges and expenses thereon from 20/05/2026.

Please take note that this is notice of **30 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.
