M/S Arabia Originals tours and travels and others had availed **OCC, MSME and GECLS** facilities mentioned above from Indian Bank, Nanapeth Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/S Arabia Originals tours and travels and others** had failed to pay the outstanding dues to the Bank. 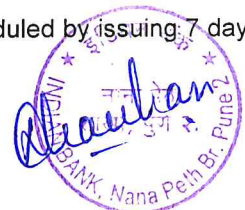

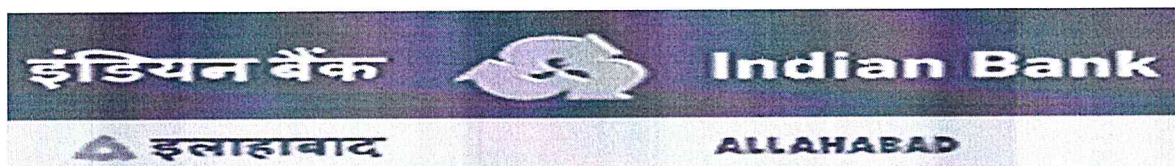

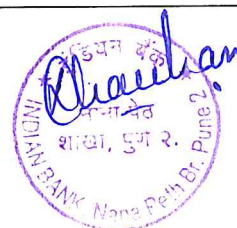
