Mr.Akash Devidas Chinchwade and others has availed home loan facility from Indian Bank, Laxmi Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Akash Devidas Chinchwade and others failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 30.09.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr.Akash Devidas Chinchwade and others liable to the Bank to pay the amount due to the tune of **Rs.45,93,711/- together** with interest from this date till date of payment within 60 days from the date of this notice issued under Sec.13 (2). Both failed to make payment despite Demand Notice dated 30.09.2024.

As Mr.Akash Devidas Chinchwade and others failed to make payment despite Demand Notice, the Authorized Officer took symbolic possession of the schedule mentioned properties under the Act on 23.12.2024 and physical possession on 06.04.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
