Mr. Ramesh Arjunrao Mule and Mrs. Ashrabai Ramesh Mule availed loan facility from Indian Bank Nanapeth Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Ramesh Arjunrao Mule and Mrs. Ashrabai Ramesh Mule** failed to pay the outstanding dues to the Bank. As **Mr. Ramesh Arjunrao Mule and Mrs. Ashrabai Ramesh Mule** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **02.02.2026** (Symbolic) and on **02.06.2026** (Physical) after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 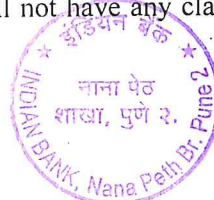

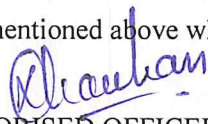

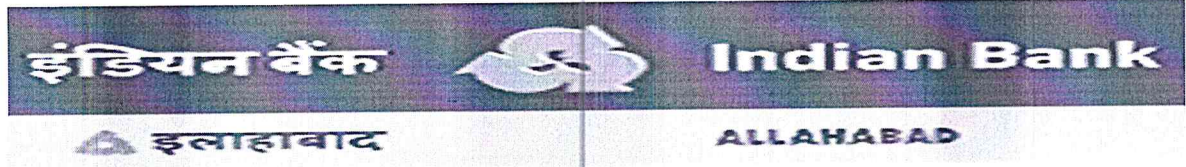
