For students who have studied a foreign language for years, the change could mean having to shift to an Indian language such as Sanskrit, Bengali, Tamil, Telugu, Punjabi, Marathi or another CBSE-approved Indian language at the Class 9 level. If the school allows it, the foreign language may continue separately as a fourth language, club, activity period or optional programme, but that will depend on the school's timetable, staffing

is available. Schools have also been asked to supplement these books with local or state-level literary material such as stories, poems or non-fiction.

The second challenge is availability of teachers. Many private schools have teachers for French, German or Spanish. But they may not have enough for multiple Indian languages.

The third challenge is the time constraint. Schools have been asked to update their R3 offerings for Classes 6 to 9 on the OASIS portal by June 30. This means schools have limited time to finalise options, rework timetables and identify teachers.
