M/s Krishna Pipes and Sheets availed OCC and TL facility from Indian Bank, Ernakulam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Krishna Pipes and Sheets failed to pay the outstanding dues to the Bank. All failed to make payment despite Demand Notice dated 27.01.2020

As M/s Krishna Pipes and Sheets failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.02.2021 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 03.06.2026 is **Rs. 4,58,71,071 (Rupees Four crore Fifty Eight lakh Seventy One thousand seventy one only)** with further interest, costs, other charges and expenses thereon from 04.06.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 24.06.2026 which would be by e-auction mode.
