Mrs.Princy Paul(Borrower) and Mr.Johnson V G (Co-Borrower) availed home loan facility from Indian Bank, Alappuzha Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties Mrs.Princy Paul(Borrower) and Mr.Johnson V G (Co-Borrower) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 02.05.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for

short called as "The Act"), was issued by the Authorized Officer calling upon **Mrs.Princy Paul(Borrower) and Mr.Johnson V G (Co-Borrower)** liable to the Bank to pay the amount due to the tune of **Rs.13,28,144/-(Rupees Thirteen lakh twenty eight thousand one hundred and forty four only)** as on 01.05.2025 with further interest, costs, other charges and expenses thereon.Both failed to make payment despite Demand Notice dated 02.05.2025

As **Mrs.Princy Paul(Borrower) and Mr.Johnson V G (Co-Borrower)** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.07.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.**

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement )Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **01.06.2026** is **Rs. 14,17,549/-(Rupees Fourteen lakhs seventeen thousand Five hundred and fourty Nine only )** with further interest, costs, other charges and expenses thereon from 02.06.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days. .

**The date of sale is fixed as 24.06.2026 which would be by e-auction mode.**

Ltd.) **for depositing in bidders EMD Wallet.** NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted.** Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction.
