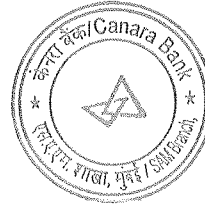

- e. 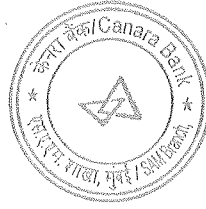
