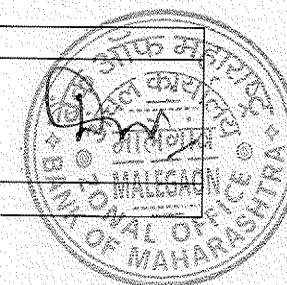
**1. Nature and Object of Online Sale:**
