

TMC’s Abhishek Banerjee roughed up on way to meet family of post-poll violence victim in Sonarpur

TMC MP and general secretary Abhishek Banerjee was heckled, and eggs were thrown at him at Sonarpur in South 24 Parganas on Saturday evening when he went to meet with the family of TMC worker Sanju Karmakar, who was killed in alleged post-poll violence.

This was the first time Abhishek was seen in public after the TMC lost in the Assembly elections.

Ahead of his arrival, groups of women, allegedly backed by the BJP, were seen standing with eggs in their hands at sev-

eral places along the road. BJP workers were seen holding black flags and chanting “Go Back” slogans.

The Diamond Harbour MP, who reached Sonarpur in a four-wheeler, had to take a motorbike ride to reach Karmakar’s residence because of the narrow lanes. This was when a group of people ghe-raoed him and started throwing bricks, eggs and shoes at him. Abhishek, who was seated in the middle on the bike, wore a cricket helmet to protect himself. As he and others accompanying him, including his security person-nel, tried to move ahead, a

group of people, chant-ing “chor chor (thief, thief)”, punched him and tore his shirt.

Undeterred, Abhishek con-tinued to walk towards Kar-makar’s home. Sources said that no police personnel were seen at the spot. A group of women was seen standing outside Karmakar’s house with brooms in their hands. They were heard shouting against the TMC leader, accus-ing him of shielding the cul-prits of RG Kar rape-murder.

“It is a BJP-sponsored protest,” Abhishek said

test. Just look at the condi-tion. We want to meet vic-tims of the post-poll viol-ence, but the police are no-where to be seen, even after being told repeatedly,” Abhishek told mediapersons after meeting Karmakar’s family.

“If they want to kill me, let them kill me. I want my body to be taken out from here... In the last 15 years, never such an incident happened. I do not expect security from this gov-ernment. Overnight bulldozers are brought in this gov-ernment. I do not expect

security from them. I will stand by the family (of Karma-kar). Referring to Sanju Karma-kar’s death, Abhishek said, “The way the boy was as-saulted, he did not say any-thing to his old parents. Close to 40-50 people had assaulted him and the police and admin-istration did not take any steps against them.”

Hitting out at the BJP for allegedly unleashing violence against TMC workers after the Assembly elections results, Abhishek further said, “I will not leave the parents (of Kar-makar) alone. I will move the High Court and petition the Governor.”

Chhattisgarh Cong leader’s son killed over sand mining rivalry, say police

A MONTH after the 18-year-old son of a Congress leader was shot dead in Chhattisgarh’s Sakti district over an alleged illegal sand-mining rivalry, police have ar-rested four men – including the alleged key conspirator.

Police said the accused alled-gedly trailed Ayush Kashyap – son of local Congress leader Sammelan Kashyap of Karhi vil-lage -- as he returned home on April 24. The assailants allegedly changed clothes to mask their identity, forced their way into the family home and locked

Ayush’s parents in a room before shooting him dead. His 16-year-old brother was also shot but sur-vived. The gang had also broken nearby CCTV cameras before the attack. Ayush’s father, Sam-melan Kashyap, a local Congress leader, had alleged at the time that his son was killed over a business rivalry linked to illegal sand mining in the area. Police now say the investigation has confirmed that angle.

Janjgir- Champa Superin-tendent of Police Vijay Kumar Pandey said: “I realised the murder had a sand-mining angle, as there have been murders linked to sand mining

in the past. I was also aware of a gang active on social media that did assaults for money and began tracking them. Another clue was the 20-minute lag be-tween the breaking of cameras and the murder, which made us suspect something was amiss.”

Police said another clue was that one of the accused, 23-year-old Bhushan Baghel, owed money to Ayush’s father. Bhushan was traced to Ahmedabad in Gujarat, while two others — Hemant Baghel, 23, and alleged shooter Amit Tondon, 28 — were arrested from the village. The fourth accused, Ganpat Baghel, was arrested Wednesday.
