M/s Trisha Packaging (Partnership Firm) availed All trade facility from Indian Bank erstwhile Allahabad Bank, Jahangirabad Branch, Bhopal the repayment of which is secured by Mortgage of schedule mentioned property/ies hereinafter referred to as "the Property/ies". M/s Trisha Packaging (Partnership Firm) failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 31.10.2022 under Sec.13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower /Guarantor / Mortgagor (s) M/s Trisha Packaging (Partnership Firm), Smt Vijaya Khandelwal W/o Late Shri Gopaldas Khandelwal (Guarantor /Mortgagor), Smt Ekta Khandelwal W/o Shri Vineet Khandelwal (Guarantor /Mortgagor), Smt Kalpana Khandelwal W/o Shri Sanjay Khandelwal (Guarantor /Partner) liable to the Bank to pay the amount due to the tune of Rs. 4,57,95,495.27/- (Rupees Four Crores Fifty-Seven Lakhs ninety-five thousand four hundred ninety-five & Twenty-Seven paise only) as on 31.10.2022 plus interest from 01.11.2022 & other charges/expenses thereon due to the Bank. All failed to make payment despite Demand Notice dated 31.10.2022.

As M/s Trisha Packaging failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.01.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The Sale Proposed to Be Held is by Way of Public Tender /Auction Adopting the E-Auction Mode.



*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 06.05.2026 is **Rs. 4,14,15,355.40 /-** (Rupees Four Crores Fourteen Lakhs fifteen thousand three hundred fifty-five & forty Paise only) plus interest from 07.05.2026 & other charges/expenses thereon. Please take note that this is **notice of 15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 05.06.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **20.05.2026 to 04.06.2026** between **10.00 AM to 04.00 PM**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
