Woman dies under mysterious circumstances

Kolkata: A young woman died under mysterious circumstances in a guest house in the Salt Lake area of Kolkata, the police said on Tuesday, adding that two persons have been arrested.

Initially, it was known that she died after falling from a mango tree. However, the family of the deceased alleged that their daughter was raped and murdered. The police later recovered the body and sent it for an autopsy.

It is learnt that the deceased woman went to the guest house in Salt Lake in an appcab on Monday night with one of her friends and two young men. She died mysteriously there.

Her companions claimed that the woman had climbed a tree, on the premises of the guest house, late on Monday night, to pick mangoes. But she fell and sustained serious injuries. She was rushed to the hospital and declared dead by the doctors. AGENCIES
