Mr. Rajesh Saini Prop. Of M/S Saini Enterprises availed Cash Credit facility from Indian Bank, **Indian Nagar** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Rajesh Saini Prop. Of M/S Saini Enterprises** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 06.11.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mr. Rajesh Saini Prop. Of M/S Saini Enterprises liable to the Bank to pay the amount due to the tune of **Rs.1,43,15,670.00 (Rupees One Crore Forty-Three Lakhs Fifteen Thousand Six Hundred Seventy Only)** as on 06.11.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.11.2024.

As Mr. Rajesh Saini Prop. Of M/S Saini Enterprises failed to make payment despite Demand Notice, the Authorized Officer took **Constructive /Symbolic/ Physical possession** of the schedule mentioned properties under the Act on 01.02.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **06.11.2024** is **Rs.1,43,15,670.00 (Rupees One Crore Forty-Three Lakhs Fifteen Thousand Six Hundred Seventy Only)** with further interest, costs, other charges and expenses thereon from **06.11.2024**.
