**Mrs. Usha Choudhary W/O Meraj & Mohd. Meraj** availed **Home loan** facility from Indian Bank, **Indian Nagar Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mrs. Usha Choudhary W/O Meraj & Mohd. Meraj** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 14.11.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), **Mrs. Usha Choudhary W/O Meraj & Mohd. Meraj** liable to the Bank to pay the amount due to the tune of **Rs.11,60,535.00 (Rupees Eleven Lakhs Sixty Thousand Five Hundred Thirty-Five Only)** as on 14.11.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 14.11.2024.

As **Mrs. Usha Choudhary W/O Meraj & Mohd. Meraj** failed to make payment despite Demand Notice, the Authorized Officer took **Constructive /Symbolic/ Physical possession** of the schedule mentioned properties under the Act on **03.02.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
