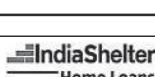
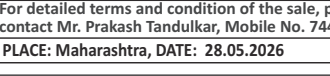

Ebola vaccine ready for trial in 3 months; SII is set to roll it out: Oxford researchers

OXFORD UNIVERSITY researchers, who are working with global partners, including the Pune-based Serum Institute of India, are rapidly advancing vaccines and treatments for the current strain of Ebola that triggered an outbreak in Congo, Uganda and South Sudan.

“Serum Institute of India (SI) is an organisation that goes far and fast. So, we are hoping to have clinical-grade vaccine doses ready within two to three months,” Professor Teresa Lambe, Head of Vaccine Immunology, Oxford Vaccine Group, Pandemic Sciences Institute, University of Oxford, told a virtual meeting on Tuesday.

Co-designer of the Oxford AZ vaccine against Covid, Prof Lambe said that researchers are aiming for a single-dose vaccine, similar to the licensed Ebola Zaire vaccine.

The vaccine effort builds on more than a decade of work with the ChAdOx platform – the technology behind the Oxford Covid-19 vaccine. Scientists say this existing knowledge has allowed them to move unusually quickly.

Oxford's manufacturing partners, including the Oxford Biomanufacturing Facility, Coalition for Epidemic Preparedness Innovations (CEPI) and the SII, are helping accelerate production and clinical preparation. Oxford is also working with global partners to accelerate the generation of supportive pre-clinical data for the development and testing of the ChAdOx-based monovalent Bundoibugyo Ebola virus candidate vaccine ChAdOx1 BDBV in outbreak scenarios.

50 CPM members held for protest against the ED

New Delhi: Around 50 CPI(M) leaders and workers were detained by Delhi Police during a protest near the ED headquarters against searches conducted at former Kerala CM Pinarayi Vijayan's residence, a senior police officer said.

According to the police officer, CPI(M) general secretary M A Baby and other party leaders, including Vijoo Krishnan and Vrinda Karat, were detained. The CPI(M) leaders had organised a march towards the ED office. But they were detained 300 metres from the ED office. Police said all the detained leaders and workers were later released.

“Several individuals whose names reportedly appeared in the CMRL diary continue to hold important positions in the state government. However, while ignoring all of them, the continuous targeting of Pinarayi Vijayan further exposes the political vendetta behind these actions,” Baby told reporters.
