The registration, verification of e-KYC, transfer of EMD in wallet and linking of wallet amount to Property must be completed well in advance, before auction.

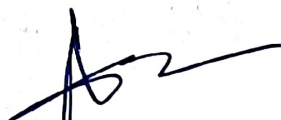
23. It is open to the Bank to appoint a representative and make self bid and participate in the auction.
