The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs. 2,91,600.00 (Rupees Two Lakh Ninety One Thousand Six Hundred Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **26/06/2026** at 5.00 PM.
