Sub: Your MSME + Home loan (HL 6560247606, SOD 6595013213, and FITL 6845224835) with Indian Bank, Kallai Road Branch – Reg.

M/S Sreelaxmi steel furniture and Mr.ShibinLal have availed MSME business loan and Home loan, facilities from Indian Bank, Kallai Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties".M/s Sreelakshmi steel furniture and others failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 15.01.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **M/S SREELAKSHMI STEEL FURNITURE AND OTHERS** liable to the Bank to pay the amount due to the tune of **Rs.54,57,804/- (Rupees Fifty four lakhs fifty seven thousand eight hundred four only) (as on 02.01.2024)** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 15.01.2024.

As **M/S SREELAKSHMI STEEL FURNITURE, Mr.ShibinLal M AND OTHERS** failed to make payment despite Demand Notice, the Authorized Officer took **possession** of the schedule mentioned properties under the Act on **24.04.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

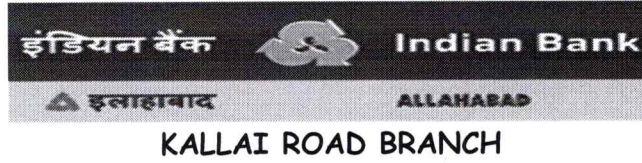
