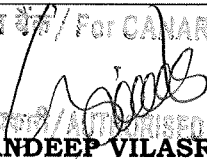


- d) EMD amount to be deposited by way ONLINE PAYMENT On BAANKNET Portal wallet in favour of Canara Bank Regional Office Kolhapur Majrewadi Branch, A/c No 209272434 IFSC Code: CNRB0015430 on or before 28.06.2026 12:00 PM.
- e) Only after payment of the EMD amount, the intending bidders shall be allowed to participate for the auction bidding process.

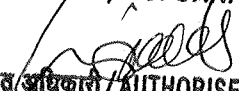
