9. Other terms and conditions:

- (a) The property/ies will be sold in "As is where is", "As is what is", and "Whatever there is" "Without Recourse" condition, including encumbrances, if any, mentioned in above table at S. - (b) The property/ies will be sold above the Reserve Price.
