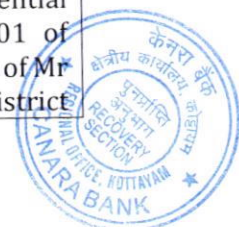

b. The property/ies will be sold above the Reserve Price.

d. 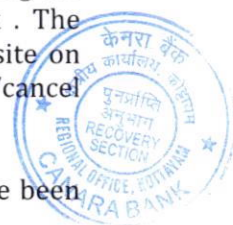
m. All charges for conveyance, stamp duty and registration, GST etc., as applicable shall be borne by the successful bidder only.
