**Sub: Your loan account/s 7326135382 with Indian Bank, Ramanattukara Branch - Reg.**

**Mr.Arjunan and Mrs.Abhirami** availed **Housing Loan** facility from Indian Bank, Ramanattukara Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr.Arjunan and Mrs.Abhirami** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **24.05.2023** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Mr.Arjunan and Mrs.Abhirami** liable to the Bank to pay the amount due to the tune of **Rs.69,34,095 (Rupees Sixty nine lakhs thirty four thousand ninety five Only)** as on **18.05.2023** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **24.05.2023**.

As **Mr.Arjunan and Mrs.Abhirami** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **08.09.2023** after complying with all legal formalities

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.**

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **05.06.2026** is **Rs. 90,20,185.00/- (Rupees Ninety lakhs twenty thousand one hundred eighty five Only)** with further interest, costs, other charges and expenses thereon from **06.06.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
