Mr.Mohammed Liyakkathali Ramammarambil and Mrs.Faseela Mohammed Liyakkathali have jointly availed HL- ELITE-NRI: 7441917275, HPLS-GEN: 7453670106, facilities from Indian Bank, M G Road, Ernakulam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Mohammed Liyakkathali Ramammarambil and Mrs.Faseela Mohammed Liyakkathali have failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.08.2024 (published in newspaper on 15.08.2024) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr.Mohammed Liyakkathali Ramammarambil and Mrs.Faseela Mohammed Liyakkathali liable to the Bank to pay the amount due to the tune of Rs. 1,34,34,388/- (Rupees One Crore Thirty Four Lakhs Thirty Four Thousand Three Hundred and Eighty Eight only) including 1) Rs.1,14,45,123/- (Rupees One Crore Fourteen Lakhs Forty Five Thousand One Hundred and Twenty Three only) for HL- ELITE-NRI and 2) Rs.19,89,265 (Rupees Nineteen Lakhs Eighty Nine Thousand Two Hundred and Sixty Five only) for HPLS-GEN as on 05.08.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.08.2024.



Mr.Mohammed Liyakkathali Ramammarambil and Mrs.Faseela Mohammed Liyakkathali failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.10.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **02.06.2026** is **Rs. 1,55,34,510/- (Rupees One Crore Fifty Five Lakhs Thirty Four Thousand Five hundred and Ten only)** (Rs. 1,31,83,948/- for HL ELITE NRI and **Rs. 23,50,562/-** for HPLS-GEN with further interest, costs, other charges and expenses thereon from **03.06.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 24th June 2026 which would be by e-auction mode.
