M/s SP Casting and (Borrower and Mortgagor) and others had availed MSME and other facilities from Indian Bank, Aurangabad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s SP Casting and (Borrower and Mortgagor) and others and others had failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17.05.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s SP Casting and (Borrower and Mortgagor) and others liable to the Bank to pay the amount due to the tune of **Rs.1,68,14,782/- (Rupees One Crore Sixty Eight Lakhs Fourteen Thousand Seven Hundred Eighty Two Only)** as on 17.05.2025 with further interest, costs, other charges and expenses thereon though all the borrower and mortgagor, guarantors failed to make payment despite Demand Notice dated 17.05.2025.

As you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.08.2025 and physical possession was taken on 30.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
